उपर्युक्त विषयक में आपके सूचना एवं आवश्यक कारवाई हेतु निम्नवत जारी किया जा रहा है।


The KVS(Hqrs) vide letter under reference on the subject cited above has informed that:

1. 4th Edition of Pariksha Pe Charcha has been proposed to be held through online mode in the 3rd week of March, 2021.
2. The Hon'ble Prime Minister will be interacting with students, teachers and parents virtually.
3. 2000 students will be selected to participate in the event on the basis of their entries in the online creative writing competition.
4. The competition is being conducted on the portal <https://innovateindia.mygov.in/ppc-2021/> on various topics enclosed as Annexure-1 from 18th February to 14th March, 2021 for children studying in classes IX to XII, teachers and parents.
5. The students are being invited to frame their questions to be addressed to the Hon'ble Prime Minister. About 20 to 30 children will be shortlisted to pose questions to be answered by the Hon'ble Prime Minister.
6. As students of KVs have actively participated and made their presence significant in all the three previous editions of Pariksha Pe Charcha, it is expected that during 4th Edition of PPC 2021, students and teachers will once again come forth and participate enthusiastically in the creative writing competitions scheduled from 18.02.21 to 14.03.21, to avail the chance of being selected for the event.
7. Creatives for the event are attached. Principals are requested to display them on the website and in all prominent places of the KV.
8. KVs are instructed to use their own social media handles as well as #ExamWarriors and #PPC2021 for dissemination of the event.
9. KVs are directed to prepare their own posters, creatives, videos etc and post them accordingly. The selected creatives will be exhibited on MyGov Platform.
10. The number of registration (Students / Teachers / Parents) done will be asked by RO min google sheet on 25th February, 2021. PLEASE DO NOT SEND ANY COMMUNICATION DIRECTLY TO KVS HQRS.
